Individual

The Zurich Invest Payment Plan allows you to receive regular payouts on your assets to meet your individual requirements. Choose either the Defensive or Opportunistic plan in line with your risk tolerance and return expectations.

Flexible

You determine the investment amount, the time frame and the duration of the distribution rate. You also decide whether distributions commence immediately or at a future point in time.

Defensive

An amount equal to three yearly withdrawals is set aside in an interest-bearing account. The remaining funds are invested as part of Zurich Invest Asset Management.

This ensures that the cash is on hand for the first three years of distributions without requiring rebalancing of the portfolio. Rebalancing occurs automatically over the remaining term in order to keep investment risk as low as possible.

How the Zurich Invest Payment Plan works

Based on your needs, you decide:

- the total amount to invest,
- whether to utilize the Defensive or Opportunistic withdrawal plan
- the distribution amount you wish to receive as complementary income or withdrawal period,
- the payout start date.

In consultation with your financial consultant, you may decide to make additional contributions, change your withdrawal plan and/or change the amount and duration of distributions. The available capital will be invested and allocated as follows:

Withdrawal plan

Defensive:

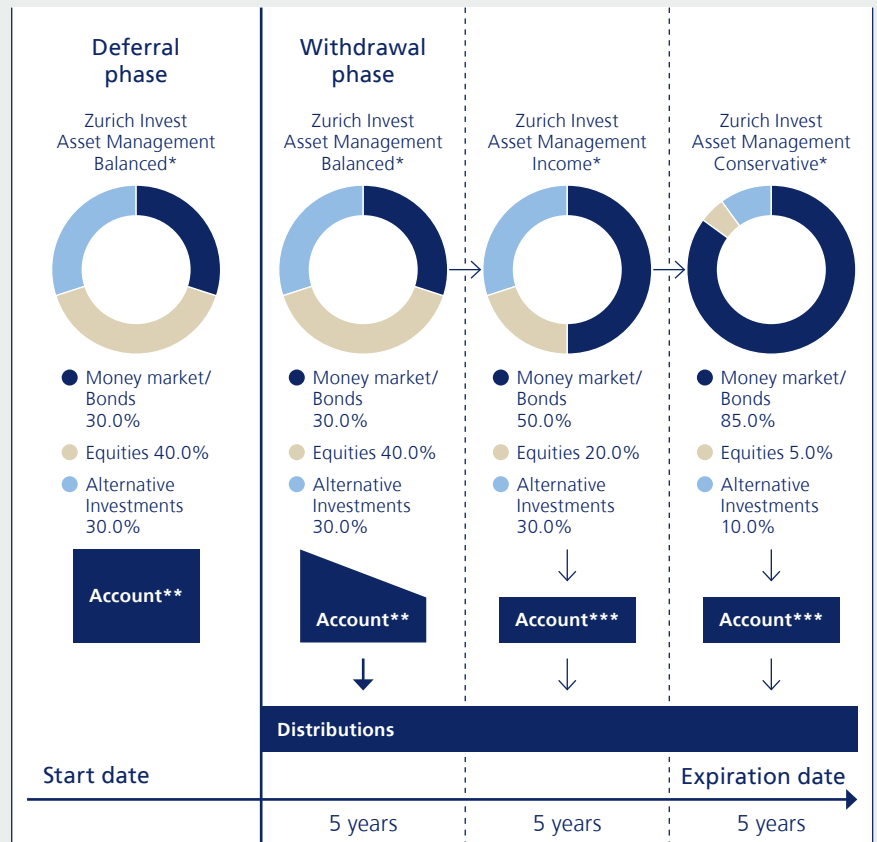
- Zurich Invest Asset Management Income* Rebalancing:
Five years prior to term expiration: switch to Zurich Invest Asset Management Conservative*

Opportunistic:

- Zurich Invest Asset Management Balanced* Rebalancing:
Ten years prior to term expiration: switch to Zurich Invest Asset Management Income*
Five years prior to term expiration: switch to Zurich Invest Asset Management Conservative*
